

## Clio Heuristic Evaluation:

In researching for this project, I performed a heuristic evaluation of Clio, a currently-available cloud-based, law firm metrics tool. For this evaluation, I took screen-captures of the tool's interface, and then evaluated it against Jakob Nielson's 10 usability heuristics for user interface design.

- 1) Visibility of system status
  - Is the principle applied? How so?
    - Side button highlighted on which page you are on.
    - 'Updated' shows how long ago it is refreshed.
    - Loading icon shows system working.
    - 'Matter created' shows that a matter has been successfully created.
    - 'No bills match your filters.' allows people to know that nothing came up on results, and the user is not waiting thinking things will load.
  - Is the principle violated? How so?
    - 'Transactions' in 'Matters' has no message to confirm nothing is there. Blank space confuses people when they expect something to come up.
  - Are there improvements that can be made? How so?
    - No blank space when things are expected there. Especially when nothing is there. When nothing came up for results, say e.g. 'No search results'.
- 2) Match between system and the real world
  - Is the principle applied? How so?
    - Iconography matches really well: 'Matters' = suitcase, 'Bills' = money, and 'Accounts' = bank.
  - Is the principle violated? How so?
    - I do not know the daily life/real world experience of attorneys, so I can not see when this principle is violated.
  - Are there improvements that can be made? How so?
    - Perhaps animations can be added e.g. paper going into a file for 'Creating a Matter', or shredding a file for 'Deleting a Matter'.
- 3) User control and freedom
  - Is the principle applied? How so?
    - 'Billable hours target' is able to transition to different time scales (week, month, year). \*Able to navigate easily through tasks with a side menu.
  - Is the principle violated? How so?
    - Reports are basic level due to limitations in their cloud platform computing.
  - Are there improvements that can be made? How so?

- Perhaps pre-calculated server analytics will allow for faster times, allowing for more insightful/advanced attorney reports.
- 4) Consistency and standards
  - Is the principle applied? How so?
    - There is a clear text hierarchy: titles are bigger and bolded, links are in blue and are underlined, and the details are below in smaller, regular text.
    - Most categories follow the same format, yet some are specified to their function.
    - Consistent layout/organization for tables.
    - All fonts consistent.
  - Is the principle violated? How so?
    - No issues I can see.
  - Are there improvements that can be made? How so?
    - Might improve green color for 'Create New' button on the top left. I feel like the green clashes with the blue a bit, but this is a minor issue.
- 5) Error prevention
  - Is the principle applied? How so?
    - Red error messages to fill out relevant information, as well as to fill out the information correctly.
    - Green text of 'Required' next to fields that are required to be filled out.
    - Have to 'confirm' to delete matters, so a user does not accidentally delete important matters/matter information.
  - Is the principle violated? How so?
    - No issues I can see.
  - Are there improvements that can be made? How so?
    - Maybe highlight boxes that are required in green so that they are easier to see rather than just the small green font. The smaller green font sometimes is hard to see against the white background.
- 6) Recognition rather than recall
  - Is the principle applied? How so?
    - 'Billable hours target' > 0 (circle) interface shows current total hours to date.
    - 'Total in Draft' and 'Total Overdue' are both easily seen, as well as color coded nicely. Blue for draft (meaning good! income) and red for overdue (meaning bad! less usable revenue).
    - Performance metrics all easily accessible, and hover to see actual values.
  - Is the principle violated? How so?
    - No issues I can see.
  - Are there improvements that can be made? How so?

- 'Edit' button in 'Matters' seems to be in the way a bit. Maybe move it to the end of the row?
- 7) Flexibility and efficiency of use
  - Is the principle applied? How so?
    - Side menu is very efficient in switching between different activities.
    - All categories are easily understandable.
  - Is the principle violated? How so?
    - While the side menu is efficient, sometimes clicking through so many things can get exhausting. So many nested menus etc.
  - Are there improvements that can be made? How so?
    - Improve the reports 'filters' interface to be more aesthetically pleasing.
- 8) Aesthetic and minimalist design
  - Is the principle applied? How so?
    - Blue color is consistent and brings a sense of security to the user.
    - Icons and text are all clear and understandable.
  - Is the principle violated? How so?
    - Filters for 'reports' are spaced too far, and could be refined to have to scroll less.
  - Are there improvements that can be made? How so?
    - Reports are just basic bar graphs, and not as flexible due to cloud computing platform.
- 9) Help users recognize, diagnose and recover from errors
  - Is the principle applied? How so?
    - Red icon under 'Announcements' or notifications easy to recognize alerts, new information and errors.
  - Is the principle violated? How so?
    - No alerts or notifications for all the side menu tabs. Users can think all is fine, when there might be urgent matters to attend to.
  - Are there improvements that can be made? How so?
    - Have alerts/notification icons on the side menu icons to attention to issues. Color code the icons e.g. red for urgent (1 day notice), and yellow for pressing/upcoming (3 day notice).
- 10) Help and documentation
  - Is the principle applied? How so?
    - Great library full of information and documentation. Users able to self-help and learn new functions.
    - Lots of support options, and material.
  - Is the principle violated? How so?

- Help page is too busy. Can overwhelm the user to give up when seeking help.
- Search all articles' menu can be minimized as well, because it detracts from the simplicity of the search bar.
- Are there improvements that can be made? How so?
  - Help center can be simplified to just a search bar. Scroll down for more options. Currently too busy, overwhelms the user.
  - Put tabs with videos so people know items are videos.
  - Also add the number of views a search item has, or how many people found it helpful.
